

## Swire Coca-Cola, USA Announces New Chief Legal Officer and Chief Information Officer

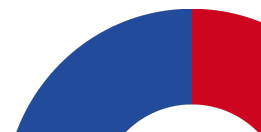

Swire Coca-Cola is also pleased to announce that Fred Bellio has officially been named Swire Coca-Cola's permanent Chief Information Officer (CIO).



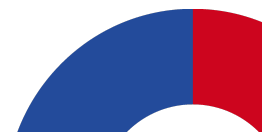
